Re: Closure of Trading Window for dealing in Company's shares

Dear Sir/Madam,

Pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015 (including the amendment(s)/re-enactment(s) thereof) and Company's Code of Internal Procedures and Conduct for regulating, monitoring and reporting of trading by Designated Persons ("the Code"), the "Trading Window" for dealing in the equity shares of the Company shall remain closed with effect from 1st July, 2021 till 48 hours after the declaration of the financial results for the quarter ended 30th June, 2021.

During the aforesaid closure period, no trading in the Company's equity shares is permitted by Promoters/Member of Promoter Group/Directors/Key Managerial Personnel/Asst. Vice Presidents and above/Employees in Accounts, Share Department & IT Department and their immediate relatives, Connected Persons covered under the Code and are, therefore requested to assiduously comply with the provisions of said Code in letter and spirit.
